<u>Draft decision 2024/A</u>: Draft work programme of the United Nations Human Settlements Programme and draft budget of the United Nations Habitat and Human Settlements Foundation for 2025, and financial, budgetary and administrative matters and the strategic plan of UN-Habitat

The Executive Board.

 - 1. *Takes note* of the report of the Executive Director on the draft work programme of the United Nations Human Settlements Programme (UN-Habitat) and the draft budget of the United Nations Habitat and Human Settlements Foundation for 2025;¹
 - [2. *Takes note* of the proposal by the Executive Director that the United Nations Habitat and Human Settlements Foundation non-earmarked budget for 2025 in line with decision 2023/4² on the scalability model [pending re-costing] [.][,] [[This proposal is] [conditional on] [taking into account] the revenue and net assets of the Foundation in 2024 [and

- [2 Alt. *Takes note* of the proposal by the Executive Director regarding the United Nations Habitat and Human Settlements Foundation non-earmarked budget for 2025, in line with decision 2023/4³ on the scalability model, pending [standard] budget re-costing as appropriate. [and taking into account the revenue and net assets of the Foundation in 2024];]
- 3. Requests the Executive Director to finalize the draft work programme and budget of UN-Habitat for 2025 based on feedback from the Committee for Programme and Coordination and the Advisory Committee on Administrative and Budgetary Questions and to present those for further consideration by the Executive Board at its second session of 2024 [taking into account the discussions in the ad hoc working group on programmatic budgetary and administrative matters];

<u>Draft decision 2024/B:</u> Implementation of the normative and operational activities of the United Nations Human Settlements Programme

The Executive Board,

- (a) Implementation of the normative and operational activities of the United Nations Human Settlements Programme.
 - 1. [*Takes note* of the report of the Executive Director on the normative and operational activities of UN-Habitat including update on [Urban Regeneration] [regeneration of urban spaces],] options and recommendations for the operationalization of the Sustainable Urban Resilience for the next Generation (SURGe), response to urban crisis, and activities for the period of July to December 2023;¹²
 - 2. [[Welcomes] [Takes note of] the update on the UN-Habitat's Flagship Programme on 'Inclusive Communities, Thriving Cities' and requests the Executive Director to continue implementing normative and operational activities and develop partnerships to promote inclusive and sustainable [urban regeneration] [regeneration of urban spaces];]
 - [2 bis. Requests the Executive Director, in line with the mandate of the Programme, as well as in accordance with resolutions 19/18 and 23/2 of the Governing Council, and decisions of the Executive Board, including decision 2022/2, paragraph 9, decision 2022/6, paragraph 3, decision 2023/2, paragraph 4 and decision 2023/5, paragraph to continue to support the efforts to reconstruct the human settlements affected by conflict and disaster, as reflected in the annex to the present document, through a comprehensive system-wide response, and to continue to provide assistance to urban crises, using urban profiling to assess the needs, vulnerabilities and capacities of urban areas and to establish urban recovery frameworks, and to submit comprehensive and up-to-date reports on the status of the development of the efforts to reconstruct the human settlements affected by

conflict and disaster, upon request by the affected Member State, to the Executive Board.]

- [3. Recalls Decision 2023/.[6] [5] of the Executive Board, and welcomes the preliminary report of the Executive Director on the "Status of the development of the efforts to reconstruct the human settlements in the Gaza Strip" and requests the Executive Director to present an updated report to the next session of the Executive Board;]
- [4. *Requests* the Executive Director, in line with the mandate of the programme, to further develop the neighbourhood-based approach to recovery and reconstruction in the Gaza Strip, to use urban profiling to deepen the assessments and to explore options for building back better;]

(b) Preparations for the twelfth session of the World Urban Forum

- 5. *Welcomes* the report of the Executive Director on the preparations for the twelfth session of the World Urban Forum; ¹³
- 6. Welcomes the selection of the city of Baku, Republic of Azerbaijan, to host the thirteenth session of the World Urban Forum in 2026;
- (c) Implementation by UN-Habitat of reforms of the development system and management of the United Nations
 - 7. *Takes note* of the Note by the secretariat and the related checklist on the implementation of the UN Development System reform in UN-Habitat and *welcomes* efforts by UN-Habitat to continue contributing to the implementation of the reform of the United Nations development system.¹⁴

The Executive Board.

- 2. *Welcomes* the efforts by the Executive Director to regularly update Member States on the progress [of all resolutions, emphasizing their implementation in a balanced manner.] [in implementing all resolutions in a balanced manner.]
- (b) Implementation of Resolution 2/5 on "Enhancing the interlinkage between urbanization and climate change resilience", specifically, operationalisation of the Sustainable Urban Resilience for the next Generation (SURGe), initiative as a meaningful institutional arrangement.
- 3. *Recalls* resolution 2/5 of the UN-Habitat Assembly ¹⁷ and [*recommends*] [*decides*] that [Option 1, where UN-Habitat supports SURGe and cooperates with partners without committing additional staff or resources under the current Strategic Planⁱ,] [Option 2, where UN-Habitat leads the SURGe secretariat and seeks to secure the necessary staff and resources through the full range of its usual resource mobilisation strategiesⁱⁱ,] [Option 3, where UN-Habitat leads the SURGe Secretariat, establishes a global coordination platform to deliver the SURGe initiative and seeks to secure the necessary staff and resources through the full range of its usual resource mobilisation strategiesⁱⁱⁱ,] is most suitable for operationalising the SURGe initiative and *requests* the Executive Director to continue working with partners to implement SURGe towards accelerated multilevel climate action within the scope of the decided option;

i Annex. SURGe to be sustained as a 'light' network

Basic elements of the SURGe initiative will be implemented without additional resource requirements to sustain the SURGe network of partners.

1. UN-Habitat's role

- a. Guiding the organization of the Ministerial Meetings on Urbanization and Climate Change at UNFCCC COPs
- b. Building partnerships and synergies in support of multilevel climate action and seeking alignment with the CHAMP Initiative
 - c. Providing NDC policy analysis for urban integration
- d. Minimum technical advisory to the five sectoral working groups with limited capacity-building support to member states and no institutional support to the SURGe Alliance
- e. Maintaining status-quo of current web presence, but no further communication and advocacy support
- f. Handing over lead coordination role of SURGe Initiative to SURGe Secretariat and limited engagement securing technical and political lead institutions per sectoral track.

2. Funding

No additional resources for post and non-post requirements will be sought (without prejudice to the framing of the 2026-2029 Strategic Plan).

ii Annex. The SURGe initiative as an entry point for accelerated climate action

Develop the SURGe initiative as an entry point for accelerated urban climate action. This supports strong collaboration with the members of the SURGe Alliance, coordinated by a dedicated UN-Habitat-led secretariat. Collectively, partners would advance multilevel climate action.

1. UN-Habitat's role:

- (a) Leading the SURGe Secretariat
- (b) Guiding and supporting the organization of the Ministerial Meetings on Urbanization and Climate Change at UNFCCC COPs
- (c) Building partnerships and synergies in support of multilevel climate action and seeking alignment with the CHAMP Initiative
 - (d) Providing NDC policy analysis for urban integration
- (e) Leveraging CHAMP pledges for accelerated multilevel climate action anchored in the updated NDCs in collaboration with the NDC Partnership
- (f) Coordinating support to and across partner-led sectoral working group tracks, including through limited support by sector specialists from across the agency.
 - (g) Seeking synergies with institutional initiatives and flagships (especially RISE UP)
- (h) Providing direct (but limited) services to Member States through the technical advisory from SURGe partners and project proposal development that contribute to accelerating multilevel climate action
- (i) Supporting the establishment of selected national SURGe strategies, city-level SURGe piloting, and limited capacity-building support through Regional SURGe focal points
- (j) Development and roll-out of communication and advocacy strategy including the establishment of a SURGe Portal for heightened visibility showcasing best practices and stimulating donor acquisition.

2. Funding:

(a) Beyond the recurrent post and non-post resources anchored in the PBI, USD1 million per year over six years will be sought from partner contributions, soft-earmarked, and project funding.

- (b) This will allow operationalizing the SURGe Initiative beyond OP2 of Resolution 2/5, which currently states to "develop options and recommendations for operationalizing the SURGe initiative as a meaningful institutional arrangement for the Executive Board to consider".
- (c) The additional resources will fund part-time Headquarter (HQ) staff and non-staff personnel as well as one regional SURGe focal point each in the Regional Offices for Africa, Arab States, Asia-Pacific, Latin America and the Caribbean.
- (d) It is expected that the annual resource mobilization for the SURGe Secretariat functions described above will leverage further USD50 million through the SURGe Alliance over six years.

iii Annex. SURGe as a global coordination platform

The SURGe initiative would provide internal coherence for UN-Habitat's climate work, accelerate the provision of support to Member States and cities and act as a coordination platform for the SURGe Alliance.

1. UN-Habitat's role:

- (a) Leading the SURGe Secretariat
- (b) Dedicated work-planning of HQ and regional staff and non-staff personnel to support multilateral processes, substance, and logistics to operationalize the Ministerial Meeting on Urbanization and Climate Change at UNFCCC COPs
- (c) Guiding and supporting the organization of the Ministerial Meetings on Urbanization and Climate Change at UNFCCC COPs
- (d) Building partnerships and synergies in support of multilevel climate action and seeking alignment with the CHAMP Initiative
 - (e) Providing NDC policy analysis for urban integration
- (f) Leveraging CHAMP pledges for accelerated multilevel climate action anchored in the updated NDCs in collaboration with the NDC Partnership
- (g) Coordinating support to and across partner-led sectoral working group tracks, including through limited support by sector specialists from across the agency.
 - (h) Seeking synergies with institutional initiatives and flagships (especially RISE UP)
- (i) Providing direct (but limited) services to Member States through the technical advisory from SURGe partners and project proposal development that contribute to accelerating multilevel climate action
- (j) Supporting the establishment of selected national SURGe strategies, city-level SURGe piloting, and limited capacity-building support through Regional SURGe focal points
- (k) Development and roll-out of communication and advocacy strategy including the establishment of a SURGe Portal for heightened visibility showcasing best practices and stimulating donor acquisition.
- (l) Development of an annual SURGe report informing negotiators of the state of multilevel climate action at the Bonn Climate Change Conferences and prior to UNFCCC COPs.
- (m) Development of global guidelines per sectoral track with technical support from Urban Basic Service Section and relevant sections
- (n) Coordination and implementation of annual SURGe governing meetings including the Global SURGe Alliance meetings.
- (o) Urban NDC implementation support through policy and proposal development, normative projects, and dedicated capacity building provided by regional SURGe focal points.
- (p) SURGe initiative as a mechanism to accelerate the implementation of all elements of the second session of UN-Habitat Assembly Resolution HSP/HA.2/Res.5.

2. Funding:

- (a) Beyond the recurrent post and non-post resources anchored in the PBI, USD5 million per year over six years will be sought through soft-earmarked, and dedicated programme funding for post and non-post cost
- (b) This will allow operationalizing the SURGe Initiative as a multistakeholder platform and convening space for peer-to-peer learning and multilevel knowledge exchange to accelerate urban climate action.

- (c) The additional resources will fund full-time HQ support staff as well as one full-time regional SURGe focal point in the Regional Office in Africa, Arab States, Asia-Pacific, Latin America and the Caribbean. In addition, the annual workplan of selected technical staff of relevant headquarters sections will prioritize the backstopping of the sectoral track working groups.
- $(d) \qquad \text{It will further fund proposal design, policy advisory, capacity-building-related activities and communication costs.}$
- (e) It is expected that this option would leverage USD 500 million over 6 years of additional project funding in support of member states.
